At all times the participants will have full control and will care, feed and keep their animal, livestock and personal property safe. All in accordance with the rules and regulations of the Expo and the show management. In no case will the Expo or Management be responsible for any loss, injury or damage to any animal, or loss, injury or damage done by or arising from any animal exhibited by him/her and shall indemnify the Expo against legal or other proceedings. Participants will indemnify and hold harmless the Expo for all damage, expenses or liabilities incurred as a result of any expense, loss, claims, cost or any liability, including, but not limited to, consultant fees, legal or court cost. A signed entry serves as an agreement to comply with all rules and regulations contained within this mailing and all other official Expo mailings.

An unsigned entry will be returned with any accompanying payment.
